Sir,

This has reference to Appeal Ref. NGSM/NBA-Acc/2011-12/1418 dated 27-12-2011 preferred by your Institution seeking review of non-accreditation of your B. Pharmacy programme as conveyed vide NBA's letter of even number dated 16-12-2011.

2. The appeal was heard by the Appellate Committee in its meeting held on 27.04.2013. The recommendations of the Appellate Committee were placed before the Sub-Committee of General Council of NBA at its meeting held on 27.08.2013. Based on the decision taken by the Sub-Committee of General Council, accreditation status of the B. Pharmacy programme is given in the Table below:

The accreditation status awarded to the programme as indicated in the above table does not imply that the accreditation has been granted to Nitte Gulabi Shetty Memorial Institute of Pharmaceutical Sciences, Paneer, Derlakatte, Mangalore, Karnataka as a whole. **As such the institution should nowhere alongwith its name including on its letter head etc., write that it is accredited by NBA because it is programme accreditation and not institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the programme(s) accredited, level of programme (UG or PG as the case may be) and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

4. The accreditation status of the above programme is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programme as indicated in the table in paragraph 2, appears on the website and information bulletin of your institution.
